## **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 2 June 2025. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

**Oral comments** concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than 5:00 p.m. on 2 June 2025. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

## **Proposed Order**

If adopted, the proposed Order will recognize the change of ownership of the fruit packing facility located at 12133 Avenue 408, Cutler, California 93615 (Facility), regulated by Waste Discharge Requirements (WDRs) Order R5-2012-0042. The proposed Order will also recognize the change in Facility name. The Facility was previously owned and operated by the Wawona Packing CO., LLC, and designated as the Cutler Fruit Packing Plant. The Facility is now owned by Jireh 1111 Holdings, LLC and operated by Jireh Packing Company, Inc. (collectively, Dischargers), and will be known as the Jireh Packing Company, Inc. – Cutler Facility. The Dischargers will be responsible for maintaining compliance with the requirements of existing WDRs Order R5-2012-0042, which regulates the discharge of up to 44,000 gallons per day of wastewater to unlined ponds for storage and reuse as irrigation water on 7.6 acres of sudan grass.
