REVISED NOTICE OF PUBLIC HEARING

TENTATIVE WASTE DISCHARGE REQUIREMENTS ORDER R5-2025-XXXX AND

TENTATIVE TIME SCHEDULE ORDER NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT CA0079049 FOR THE CITY OF DAVIS WASTEWATER TREATMENT PLANT YOLO COUNTY

Discharger and Tentative Order Information

The City of Davis (Discharger) is the owner and operator of the City of Davis Wastewater Treatment Plant (Facility), located at 45400 County Road 28H, Davis, California. The Discharger provides sewerage service for the community of Davis and serves a population of approximately 68,000. The design average dry weather flow capacity of the Facility is 7.5 MGD. Tertiary treated disinfected wastewater from the Facility is discharged to Willow Slough Bypass and seasonally to the Main Conaway Canal, seasonally to groundwater via percolation from the Davis Wetlands and if the Davis Wetlands reach capacity during the rainy season, the Conaway Ranch Toe Drain. Willow Slough Bypass, the Main Conaway Canal, and the Conaway Ranch Toe Drain are all waters of the United States within the Yolo Bypass and Sacramento River Watershed.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2018-0086, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 7 December 2018. An Order is proposed to renew the National Pollutant Discharge Elimination System (NPDES) Order. The tentative NPDES Order includes new or updated effluent limitations for ammonia, total copper, and total cyanide plus chronic toxicity whole effluent toxicity effluent limitations per the new Statewide Toxicity Provisions. The tentative NPDES Order includes new land discharge specifications and monitoring, additional pond monitoring, along with increased groundwater monitoring requirements to monitor discharge to land from the Emergency Storage Ponds, Stormwater Percolation Ponds and/or the Recycled Water Storage Ponds. The tentative NPDES Order includes new special studies to evaluate the work needed for soil remediation of the former treatment ponds that are now used as storage ponds. The tentative NPDES Order also includes a compliance schedule for the Discharger to complete the installation of a liner at the Emergency Storage Ponds to protect high quality groundwater beneath the Facility.

The proposed tentative Time Schedule Order includes a compliance schedule with milestones for the Facility to come into compliance with total copper and cyanide effluent limitations.

Nature and Purpose of Hearing

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Orders. This proceeding will be a formal adjudicatory proceeding. The <u>procedures governing Central Valley Water Board adjudicatory hearings</u> (http://www.waterboards.ca.gov/laws_regulations/) may be found at California Code of Regulations, title 23, section 648 et seq. and are available upon request.

Prehearing Submission of Written Comments and Evidence

The Discharger is a party to this proceeding. As a party, the Discharger must submit written evidence or comments, if any, for the Board to consider no later than 5:00 p.m. on **16 January 2025** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Interested persons include any non-party that is interested in the outcome of the hearing. Interested persons wishing to comment, in writing, on the tentative Orders shall submit comments no later than 5:00 p.m. on **16 January 2025** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

Requesting Party Status

Persons who wish to participate in the hearing as a party must submit a request in writing no later than 5:00 p.m. on **28 December 2024** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov. The request must include facts demonstrating how the person will be substantially affected by the proceeding.

The Board Chair will not designate a person as a party if the Board Chair determines the designation will impair the interests of justice and the orderly and prompt conduct of the proceeding. The Board Chair, when granting a request for party status, may impose restrictions on the requestor's hearing participation, including limiting or excluding the use of cross-examination and other procedures to promote the orderly and prompt conduct of the proceeding.

Prehearing Submission of Written Comments and Evidence

The written comment period has closed for this item. Interested persons were previously invited to submit written comments concerning the tentative Order. Pursuant to the Notice of Public Hearing, dated 17 December 2024, comments were due by 5:00 p.m. on 16 January 2025.

Written materials submitted after the close of the written comment period will not be accepted and will not be incorporated into the administrative record, absent a ruling by the Board Chair.

Visual Presentations

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on 17 June 2025.

Hearing Procedure and Time Limits

The hearing on the tentative Orders will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** and any other designated Party will be advised in advance of the hearing of the total amount of time allocated for their presentation and closing statement. The Discharger and Parties are invited to contact staff in advance of the hearing to discuss how much time they believe is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.

Hearing Accommodations

The hearing facilities will be accessible to persons with disabilities.
