NOTICE OF PUBLIC HEARING CONCERNING

RESCISSION OF WASTE DISCHARGE REQUIREMENTS FOR CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION DEUEL VOCATIONAL INSTITUTION CLASS II SURFACE IMPOUNDMENTS SAN JOAQUIN COUNTY

Enclosed for your review is a copy of the tentative agenda item to rescind waste discharge requirements (WDRs) Order R5-2017-0071 for Deuel Vocational Institution's Class II surface impoundments in San Joaquin County. The WDRs are being considered for rescission since the surface impoundments have been clean closed and they are no longer subject to the State Water Resources Control Board-(SWRCB) promulgated requirements of Title 27 regulations. Also enclosed is a notice of public hearing (NOPH) to interested parties, pursuant to California Code of Regulations, title 27, section 21730. The enclosed NOPH describes the date, time, and place that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) is scheduled to have a hearing to consider rescission of WDRs Order R5-2017-0071.
