TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS ORDER 99-046, INDIAN VALLEY COMMUNITY SERVICES DISTRICT, GREENVILLE WASTEWATER PONDS, PLUMAS COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Order for Rescission of Waste Discharge Requirements for the Greenville wastewater ponds (Facility). To be given full consideration, any comments or recommendations you have concerning the tentative Order must be submitted in writing to the Central Valley Regional Water Quality Control Board (Central Valley Water Board) office by **5:00 pm on 17 October 2025**. Written materials submitted after this date and time will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. Please note that the tentative documents will receive internal legal and management review during the public comment period.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the tentative Order at its **11/12 December 2025** Board Meeting. The Notice of Public Hearing (4 copies) and a copy of a Proof of Posting form are also enclosed. **By 23 September 2025** post one (1) copy of the Notice of Public Hearing at:

- The entrance to the Facility;
- The nearest city hall or county courthouse; and
- The post office nearest to the Facility (if allowed).

Proof of posting, using the enclosed form, shall be filed with this office by **29 September 2025**.

To conserve resources, this letter transmits a paper copy of the tentative documents to the Discharger only.
