## **PUBLIC HEARING**

### TENTATIVE ORDER

WASTE DISCHARGE REQUIREMENTS ORDER R5 2025-####  
JEN CALIFORNIA 26, LLC  
STONE BEETLAND PROJECT  
SACRAMENTO COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the Jen California 26, LLC (Permittee), Stone Beetland Project (Project) in Sacramento County. The 122-acre Project consists of developing the project site for approximately 1,163 residential units spread between four villages: the Transit Village, North Village, Central Village, and West Village and include mixed-use, residential, and commercial development designed with a park or open space as a central focal element. The Project includes the construction of parks, landscape corridors, open spaces, landscape lots, drainage basins, and an internal roadway system with primary site access provided by Cosumnes River Boulevard. The Project is a Transit Priority Project, incorporating a Sacramento Regional Transit light-rail station in the Project's design. Construction of the Project will result in the placement of fill material into 0.32 acres/2,598 linear feet of Waters of the State, consisting of 0.032-acre of ephemeral ditch (148 linear feet), and 0.290-acre of intermittent ditch (2,450 linear feet).

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities that allow for activities to meet Basin Plan objectives.

Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than 5 p.m on 13 January 2025. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to [Nicholas.Savino@waterboards.ca.gov](mailto:Nicholas.Savino@waterboards.ca.gov) no later than by 5:00 p.m. on 13 January 2025. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
