NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. R5-2025-0527

**JAGPAL S. BATTH, OWNER/OPERATOR
SAN JOAQUIN COUNTY**

NOTICE IS HEREBY GIVEN THAT the Central Valley Regional Water Quality Control Board (Central Valley Water Board) is releasing for public comment proposed Administrative Civil Liability (ACL) Complaint Number R5-2025-0527 issued to Jagpal S. Batth (Discharger), in the amount of **\$28,665**. The complaint alleges that the Discharger failed to obtain Irrigated Lands Regulatory Program coverage as required by California Water Code (Water Code) section 13260 for his 125-acre cropland in San Joaquin County. By failing to comply with the requirement, the Discharger is subject to liabilities pursuant to Water Code section 13261.

State law requires water quality permits for commercial irrigated lands to ensure waste discharges from these operations do not harm the Central Valley's rivers and groundwater aquifers.

In March 2014, the Central Valley Water Board issued Waste Discharge Requirements General Order R5-2014-0029, which allowed farmers in the San Joaquin County and Delta Area to obtain regulatory coverage by joining an approved third-party group, the San Joaquin County and Delta Water Quality Coalition (Coalition). The Coalition conducts monitoring, assessments, data collection, and provides reports to the Central Valley Water Board on behalf of its members. Growers who elect not to participate in a third-party group may alternatively obtain individual coverage under Waste Discharge Requirements General Order R5-2013-0100 (Individual General Order). Owners and operators of commercial irrigated lands who do not obtain regulatory coverage via one of the above options are subject to fines.
