The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party's subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than 5:00 p.m. on 7 July 2025. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Order R5-2025-XXXX will revise current waste discharge requirements for the discharge of wastewater to land from operations at the Mission Bell Winery located at 12667 Road 24, Madera, Ca 93637. The Mission Bell Winery is owned and operated by Constellation Brands US Operations, Inc. (Discharger) and is currently regulated by Waste Discharge Requirements Order No. 95-164. The current Order authorizes the seasonal operational discharge of 1.0 to 2.94 million gallons per day of winery waste to

296 acres of adjacent land application areas (LAA). The proposed WDR Order authorizes continued land application to 296 acres and the following:

- Annual flow limit of 255 million gallons
- Seasonal flow limits for stillage waste
- Performance Based Salinity Limit Salinity limit of 1,850 mg/L
- Biochemical oxygen demand cycle average loading to the LAAs shall not exceed 100 lbs/ac/day
- Prohibition on introducing ion exchange waste to the discharge
- Preparation and implementation of a Wastewater and Nutrient Management Plan
- Preparation and implementation of a Salinity Evaluation and Minimization Work Plan and Final Report
- Effluent, LAA, groundwater, and soil monitoring
