Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed change of ownership Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is a designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Proposed Order

If adopted, the proposed Order will transfer ownership of the McCarthy Family Farms Inc Evaporation Basin, which is regulated under Waste Discharge Requirements (WDRs) Order 93-163, to Sandridge Partners (Discharger). WDRs Order 93-163 prescribes requirements for management of an evaporation basin, located about 13 miles southwest of Corcoran in Sections 21 and 28 of T23S, R21E, MDB&M. The Discharger will be responsible for maintaining compliance with Order requirements.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
