The enclosed tentative Rescission Order is to rescind Waste Discharge Requirements (WDRs) Order R5-2013-0137 for the Seka Hills Olive Mill. Order R5-2013-0137 prescribes requirements for the discharge of wastewater from olive oil processing operations to land application areas located within three (3) separate parcels. Rescission of Order R5-2013-0137 is being considered based on lot line adjustments of the parcels and transfer of land ownership from "Fee Land" to "Trust Land" as summarized in the table below.
