### **NOTICE OF TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR SAN FRANCISCO PUBLIC UTILITIES COMMISSION, 2023 STORMS – SITE J14B REPAIRS PROJECT, TUOLUMNE COUNTY**

#### **TO ALL CONCERNED PERSONS AND AGENCIES:**

Enclosed are tentative Waste Discharge Requirements for the 2023 Storms – Site J14b Repairs Project (Project) in Tuolumne County.

The Project will include repair activities at Site J14b where storm surge events in 2023 clogged and damaged an existing 24-inch diameter corrugated metal pipe (CMP) culvert that conveys an ephemeral stream crossing under a dirt access road. Repair activities include upsizing the 24-inch CMP culvert with a 36-inch CMP culvert, installing a headwall, endwall, and associated wingwalls, placing rock slope protection (RSP) at the inlet and outlet of the culvert, recontouring the area up and downstream of the culvert, and performing necessary road rehabilitation/stabilization.
