### TENTATIVE ORDER

WASTE DISCHARGE REQUIREMENTS ORDER R5-2026-####  
SAN FRANCISCO PUBLIC UTILITIES COMMISSION  
2023 STORMS – SITE M5A REPAIRS PROJECT  
TUOLUMNE COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the San Francisco Public Utilities Commission (Permittee), 2023 Storms – Site M5a Repairs Project (Project) in Tuolumne County. The Project will include repair activities at Site M5a where storm surge events in 2023 clogged and damaged an existing 24-inch diameter by 20-foot-long corrugated metal pipe (CMP) culvert. Repair activities include upsizing the 24-inch CMP culvert with a 36-inch CMP culvert, installing a headwall, endwall, and associated wingwalls, placing rock slope protection (RSP) at the inlet and outlet of the culvert, recontouring the area up and downstream of the culvert, and performing necessary road rehabilitation/stabilization.

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities that allow for activities to meet Basin Plan objectives.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Interested persons may not cross examine witnesses and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board **no later than 5 p.m. on 29 April 2026**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to [Jenna.Yang@Waterboards.ca.gov](mailto:Jenna.Yang@Waterboards.ca.gov) **no later than by 5:00 p.m. on 29 April 2026**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
