Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the rescission Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 24 July 2025. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The parties subject to the proposed Order are designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on **24 July 2025**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Rescission Order R5-2025-XXXX will rescind Waste Discharge Requirements (WDRs) Order R5-2009-0054, which prescribes requirements for the discharge of domestic wastewater from the Taft Federal Prison Wastewater Treatment Facility (Facility) located at 1510 Cadet Rd, Taft, CA 93268. WDRs Order R5-2009-0054 was adopted in April 2009 and authorizes the discharge of domestic

wastewater up to 0.46 million gallons per day from the Facility to land. Operations at the Facility are reported to have ceased around 2020. Central Valley Water Board staff (Staff) conducted an inspection of the Facility on 6 November 2024 and observed that the Facility was inactive. On 28 February 2025, the Discharger sent an email to Staff requesting that WDRs Order R5-2009-0054 be rescinded due to the prison's closure on 30 April 2020. In addition, the Discharger submitted a workplan describing the planned activities to close of the Facility. Reports and supplemental information documenting completion of workplan activities were submitted by the Kern County Department of Public Works and the Discharger on 29 April 2025 and 5 May 2025. On 6 May 2025, Central Valley Water Board staff sent a letter deeming that the closure workplan was complete.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
