Enclosed are tentative Waste Discharge Requirements (TWDRs) and tentative Monitoring and Reporting Program (MRP) for the Controlled Environment Foods Fund II Tehachapi Property, LLC (CEFF II or Discharger), CEFF II Tehachapi Greenhouse (Facility). The Central Valley Regional Water Quality Control Board (or Central Valley Water Board) will consider adopting the TWDRs at its 22/23 August 2024 Board Meeting. Any written comments or evidence you may have concerning these items must be submitted to this office by **5:00 pm on 22 July 2024**. Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.
