WASTE DISCHARGE REQUIREMENTS ORDER R5 2026-####
TEICHERT MATERIALS
ASPEN VIII AND IX EXPANSION PROJECT
SACRAMENTO COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the Teichert Materials (Permittee), Aspen VIII and IX Expansion Project (Project) in Sacramento County. The Project will expand aggregate surface mining operations at the existing Teichert Materials Aspen VIII and Aspen IX mining sites. The expansion areas will add 245.6 acres of surface mining operations for sand and gravel.

As a part of the expansion, Teichert is proposing to extend its existing electric conveyor belt system over Elder Creek to transport aggregate materials from Aspen IX to the Perkins processing facility, which will require a crossing of Elder Creek. The crossing, which will consist of a free-span rail-car bridge 50 feet long by 28 feet wide, will be installed without direct effects to Elder Creek.

The Project site supports 16.19 acre of waters of the state, including vernal pools, seasonal wetlands, a seasonal pond, and a portion of Elder Creek. While Elder Creek will be avoided, mining operations will permanently impact all other waters of the state located on the Project site.

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce on-site impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities that allow for activities to meet Basin Plan objectives.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. Interested persons may not cross examine witnesses and will not be subject to cross examination. Interested persons may submit evidence (e.g., photographs, eye-witness testimony, monitoring data) if the evidence is submitted in accordance with the deadlines for submitting evidence described below. Interested persons who present evidence may be subject to cross-examination. Interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board **no later than 5 p.m on 29 April 2026**. The request must explain the basis for status as a designated party and in particular how the person is affected by the discharge.

Persons wishing to comment on this item must submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board via email to Nicholas.Savino@waterboards.ca.gov **no later than by 5:00 p.m. on 29 April 2026**. Written materials submitted after 5:00 p.m. on the above date will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that the late submission would not prejudice the Central Valley Water Board or any designated party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.


