The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party. Oral comments concerning the Order must be presented at the scheduled public meeting. Interested persons are generally allowed up to three minutes each to provide their comments. Certain designated persons may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The person(s) subject to the proposed Order is/are designated person. Any other person may request recognition as a designated person by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated person. **Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on 1 June 2026.** Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

The University of California (UC) Regents (Discharger) is the owner and operator of the UC Davis Wastewater Treatment Plant (Facility), located at 561 Trotter Way, Davis, CA 95616. The Discharger provides sewerage service for UC Davis and serves a campus population of approximately 48,000. The design daily average flow capacity of the Facility is 3.6 million gallons per day. The Facility discharges tertiary-treated wastewater to the South Fork of Putah Creek and the Arboretum Waterway, waters of the United States. Discharges from the Facility are currently regulated by Order R5-2021-0007, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 18 February 2021. Based on the Report of Waste Discharge and subsequent information submitted by the Discharger, staff determined that the Facility is eligible for coverage under the General Order R5-2023-0025 for Municipal Wastewater Dischargers That Meet Objectives/Criteria at the Point of Discharge to Surface Water (Municipal General Order). A Notice of Applicability (R5-2023-0025-018) was issued by the Central Valley Water Board's Executive Officer with an effective date of 1 October 2026. Since regulatory coverage for the discharge of treated wastewater to surface water will be provided under the Municipal General Order, Order R5-2021-0007 is no longer necessary. Rescission of Order R5-2021-0007 is proposed for the Facility.
