NOTICE IS HEREBY GIVEN that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider a Tentative Amending Order to amend Waste Discharge Requirements (WDRs) Order R5-2006-0019-001 for El Dorado County (hereafter Discharger), Union Mine Septage/Leachate Treatment Facility (Facility) at a public meeting scheduled for:

The date, time, and location of the public meeting may change after this Notice is issued. A Final Agenda for the meeting will be made available at least 10 days before the meeting. The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed Order will be considered, and the anticipated Order of all agenda items; however, the Board may consider agenda items out of their listed Order. The agenda materials may also include staff revisions to the proposed Order.

Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 3 November 2025. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have

the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is a designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than **5:00 p.m. on 3 November 2025**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

The Facility is regulated under R5-2006-0019-001, which was amended by Order R5-2021-0010 on 18 February 2021. The Facility receives Class II leachate generated from the Union Mine Landfill, condensate generated during extraction of landfill gas, and septage and portable toilet wastewater generated throughout El Dorado County.

Amending Order R5-2021-0010 states that the monthly average inflow to the Facility shall not exceed 20,000 gallon per day (gpd). However, the Discharger may submit a request to the Executive Officer, and upon approval, the Executive Officer may authorize increasing the flow limit up to the disposal capacity of 22,000 gpd.

On 18 June 2025, the Discharger submitted a Report of Waste Discharge to request the influent flow limit increase from 20,000 to 22,000 gpd as a monthly average and proposed to install an effluent zinc reduction system to meet the effluent limit. The WDRs Order R5-2006-0019-001 will be amended to increase the influent flow limit to 22,000 gpd as a monthly average and to include the proposed zinc reduction system. The proposed Tentative Amending Order is attached.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order will be sent only to the Discharger.
