Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 20 June 2025. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is the designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than **5:00 p.m. on 20 June 2025**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-2025-XXXX will prescribe requirements for management of waste discharged from the White Slough Water Pollution Control Facility (Facility), located at 12751 Thornton Road in Lodi. The Facility is owned and operated by the City of Lodi (Discharger). The Discharger will be responsible for maintaining compliance with Order requirements. The Facility is a wastewater treatment plant that collects and treats domestic and industrial wastewater. Treated domestic wastewater (recycled wastewater) and industrial wastewater are used for irrigation of crops in the fields surrounding the Facility, and biosolids are used as a soil amendment. Recycled water is also supplied to other non-city facilities located on site. The Facility's waste discharges to land are currently regulated under WDRs Order R5-2007-0113-01 and under the site-specific notice of applicability (NOA) WQ 2016-0068-DDW-R5007. If adopted, the proposed WDRs Order R5-2025-XXXX will rescind and replace the previous WDRs Order and will result in inclusion of land application requirements previously regulated under NOA WQ 2016-0068-DDW-R5007, and inclusion of the Salt and Nitrate Control Programs, among others.
