Century Center Cleaners 2401 East Orangeburg Avenue, Modesto, California

Proposed No Further Action Determination Public Comment Period:

14 May 2025 – 14 June 2025

PUBLIC NOTICE:

The public is invited to comment. Century Center Cleaners requests no further action. Century Center Cleaners is at 2401 East Orangeburg Avenue in Modesto, Stanislaus County, California. Figure 1 is a map showing the location of the property.

CASE SUMMARY:

The property is a shopping center. There used to be a dry cleaner business at the property. The property buildings have restaurants, shops, and a martial arts studio.

The dry cleaner used the solvent PCE to clean clothes. PCE leaked into soil and groundwater at the property. PCE can be of concern in air or drinking water. Cleanup at the property removed PCE from soil vapor and from groundwater. There is still some PCE in soil vapor beneath buildings at the property, but at levels low enough for safe use of the property. PCE in groundwater around the building is below the California maximum contaminant level for drinking water.

PCE in soil vapor under the buildings and in groundwater are at low enough levels that they do not pose a risk to humans or the environment. The chemicals in indoor air could pose a risk if the land use on the property changed. Century Center Cleaners proposes no further action. The proposal will include a Land Use Covenant (LUC). The LUC will be added to the property's deed. The LUC will limit land use to the current commercial business use.
