The Central Valley Regional Water Quality Control Board (Central Valley Water Board) is preparing a Notice of Applicability for the Elm Dry Cleaners property in Auburn, California for coverage under General Order No. R5-2015-0012, Waste Discharge Requirements General Order for In-situ Groundwater Remediation and Discharge of Treated Groundwater to Land. Coverage under the General Order will allow the property owners to add specific compounds to groundwater to promote the breakdown of groundwater pollutants at the property. Environmental assessment and remedial action are being performed under the oversight of the Central Valley Water Board.

Project Description:

A dry-cleaning facility has operated at the 365 Elm Avenue property since approximately 1962, and tetrachloroethene (PCE) was used in dry-cleaning operations until 2007. The primary contaminants of concern in soil, soil vapor, and groundwater are PCE and its breakdown products. The proposed project involves the injection of a biodegradable electron donor emulsion and a bioaugmentation culture into groundwater to promote the biological conversion of PCE and its breakdown products to harmless end-products (e.g., ethene).

Remediation amendments will be introduced into groundwater via a series of wells located at the 365 Elm Avenue property. Groundwater wells are currently being installed. The draft Notice of Applicability will be finalized following well installation, groundwater sample collection, and identification of specific well locations for amendment injection and monitoring. Once the draft Notice of Applicability is finalized, it will be available on the Central Valley Water Board website (https://www.waterboards.ca.gov/centralvalley/board_decisions/tentative_orders/#placerco). The document will available under the "Placer County" heading on the Tentative Orders page of the website.
