The Central Valley Regional Water Quality Control Board (Central Valley Water Board) invites public comment on a Notice of Intent (NOI) application for the Florin Towne Center cleanup site located at 6117 Florin Road in Sacramento, Sacramento County, California (Site). The NOI seeks coverage under General Order R5-2015-0012, Waste Discharge Requirements General Order for In-situ Groundwater Remediation and Discharge of Treated Groundwater to Land. Coverage under the General Order will allow the property owner to inject amendments into groundwater under the oversight of the Central Valley Water Board to aid in the breakdown of pollutants present in groundwater at the property.

Project Description:

The solvent tetrachloroethylene (PCE) was discharged to soil and groundwater at the Site as a result of operations at the property between the 1960s and 2000s. Previous injections have resulted in significant reductions in groundwater pollution at the Site, but additional cleanup is needed. The proposed project will inject a mixture of a carbon source and bacteria into the subsurface at 8 locations at the Site. The mixture is able to break down PCE and other volatile organic compounds. The injection project is expected to last 5-7 days. Groundwater quality will be monitored before, during, and after the injections to ensure no negative impacts occur outside the injection area.
