This serves as notice that the Central Valley Regional Water Quality Control Board ("Central Valley Water Board") has prepared an Agreement and Covenant Not to Sue (the "Agreement") concerning the Former Haley's Flying Service Site, located at 2395 East Pescadero Avenue (historically referred to as 21000 South Paradise Road), Tracy, California ("Site"). The Central Valley Water Board invites public comment on the proposed Agreement.

Historically, the Site was an agriculture crop-dusting facility that operated from approximately 1951 to about 1989. The Site included hangar buildings, an office, a concrete-lined washout pit for rinsing aircraft agricultural chemical tanks, a loading dock, and a concrete-paved area for storing and handling agricultural pesticides. Two underground fuel storage tanks were removed from the Site in or about 1990. A narrow strip of remnant pavement traverses the Site from east to west; this feature is believed to be the former airstrip used by Haley's Flying Service. This former agricultural airstrip and crop-dusting facility is believed to have been a source of organochlorine pesticide contamination and low concentrations of diesel and motoroil range petroleum hydrocarbons in the soil at the Site.

The Central Valley Water Board has regulatory authority to require the investigation and cleanup of contaminated properties. The Central Valley Water Board also has the authority to enter into agreements with prospective purchasers of such properties when doing so is in the public interest. Several environmental investigations have taken place at the Site dating back to the 1970s.

Ridge Tracy Land Partners No. 2 LLC ("Ridge Tracy") seeks to purchase and redevelop the Site. Ridge Tracy has proposed a soil excavation and removal plan to address pesticide-impacted soils at the Site. The Central Valley Water Board has approved the proposed soil excavation and removal plan and determined that groundwater remediation is unnecessary.

The Central Valley Water Board and Ridge Tracy intend to enter into the Agreement to release Ridge Tracy from environmental liability associated with the existing contamination at the Site in consideration of Ridge Tracy's performance of the proposed soil excavation and

removal plan. The Central Valley Water Board plans to require an environmental land use restriction to be recorded concerning the Site.
