PUBLIC NOTICE: PROPOSED PETROLEUM UNDERGROUND STORAGE TANK CASE CLOSURE

PUBLIC COMMENT PERIOD: 07 February through 08 April 2025

LARRY'S AUTO; 308 N. GRANT STREET, STOCKTON, SAN JOAQUIN COUNTY; LUST CASE #390170, GLOBAL ID T0607700119

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) invites public comment on the proposed case closure of the Larry's Auto petroleum Leaking Underground Storage Tank (tank) release case, located at 308 N. Grant Street in Stockton, CA (Property). A map showing the investigation area and the current remaining extent of petroleum impact to groundwater is attached as Figure 1.

The Property has two buildings, the Larry's Auto building and adjoining building which has been occupied by various businesses. Between 1987 and 1990, the Property owner removed four petroleum tanks from the Property which had leaked. Between 1996 and 2023, the Property owner and their consultants investigated the petroleum contamination. Between 2008 and 2016, they cleaned up the contamination with a remediation system. The cleanup efforts removed **15,800 pounds** (approximately 2,630 gallons) of petroleum from beneath the Property.

The current consultant working on the case, Advanced Geo Inc., has concluded that petroleum remaining in the ground does not pose a significant threat to human health, the environment, or future property activities. The Central Valley Water Board staff is issuing this notice to you and providing a 60-day public comment period to the owners and occupants of all properties near the Property and other interested parties. Central Valley Water Board staff will consider comments received when evaluating the case closure.
