### **PUBLIC NOTICE: PROPOSED PETROLEUM UNDERGROUND STORAGE TANK CASE CLOSURE**

**PUBLIC COMMENT PERIOD:** 15 January 2026 to 16 March 2026

**REINKE'S CHEVRON; 10115 LA PORTE ROAD, CHALLENGE, YUBA COUNTY;

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) invites public comment on the proposed case closure of the Reinke's Chevron leaking underground storage tank (tank) case, located at 10115 La Porte Road in Challenge, CA (property). A map showing the location is attached as Figure 1.

In February 1995, the property owner removed three underground storage tanks (tanks) from the property. Soil samples collected beneath the tanks contained petroleum, indicating an unauthorized release of petroleum had occurred at the property. The property owner conducted additional investigations in August 2025 to assess the extent of petroleum contamination in soil and soil vapor, and to determine if the release had contaminated groundwater. Residents in the area of the groundwater contamination (Figure 1) receive municipal water and do not use domestic groundwater wells.

The property owner's consultant working on this project has concluded that petroleum remaining in the ground does not pose a significant threat to human health, the environment, or future property activities. The remaining petroleum in soil and soil vapor will naturally break down within a reasonable amount of time. The consultant recommended case closure under California's Low-Threat Closure Policy. Central Valley Water Board staff will consider public comments during case closure review.

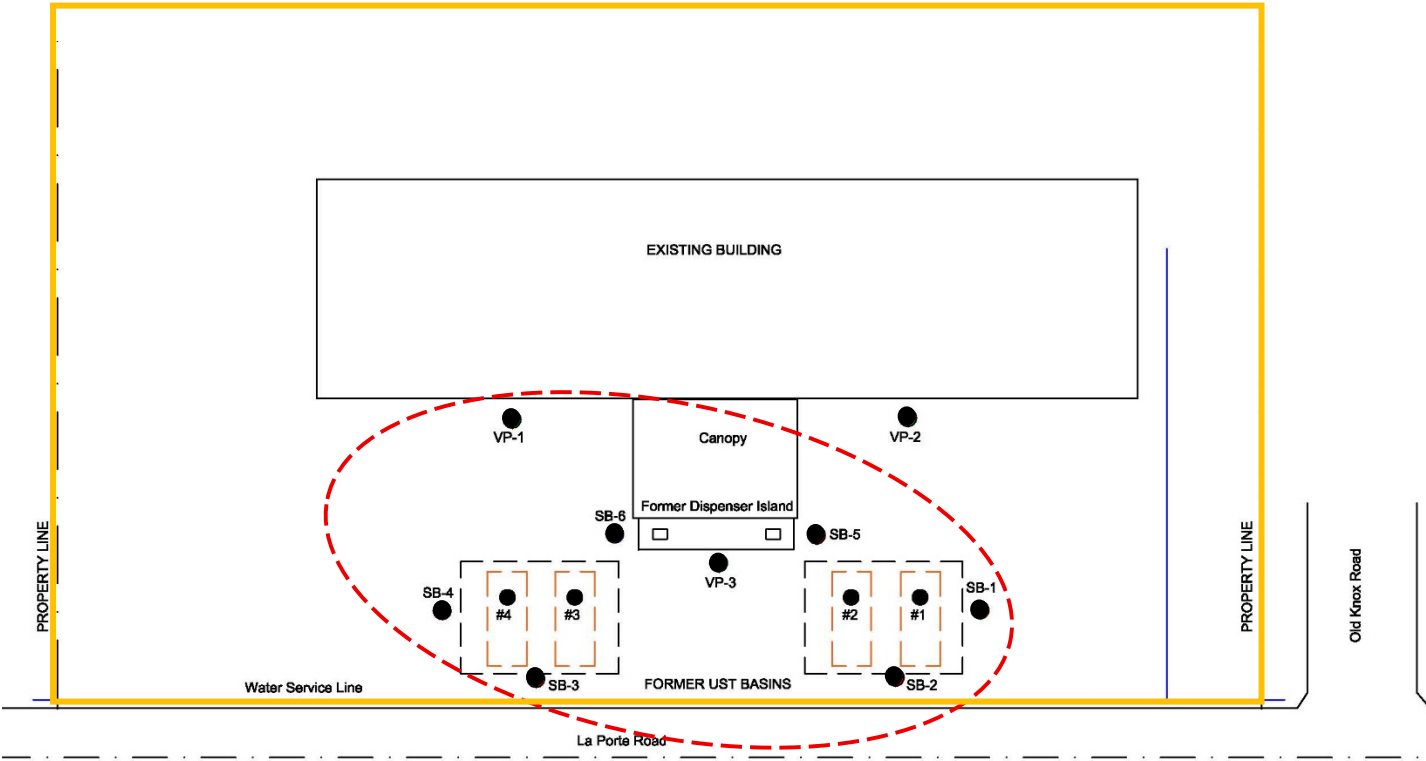
