### **NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION AND OPPORTUNITY TO PROVIDE COMMENTS ON THE PROPOSED PLEASURE COVE MARINA II PROJECT, NAPA COUNTY**

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) is the California Environmental Quality Act (CEQA) lead agency for the Pleasure Cove Marina II Project (Project). A proposed Negative Declaration (ND) describing potential adverse environmental impacts has been prepared by the Central Valley Water Board in connection with this Project. This request for comments is intended to provide interested individuals, organizations, and agencies the opportunity to comment on the environmental effects of the Project as described in the proposed ND.

**Project Location:** The Project is located within the existing Pleasure Cove resort and marina in Lake Berryessa in eastern Napa County. The address of Pleasure Cove Marina is 6100 CA-128, Napa, CA, 94558. The lake is surrounded by federal land managed by the U.S. Bureau of Reclamation.

**Project Description:** The primary goal of the Project is to add five floating dock structures with a total of 158 boat slips to the existing marina. The floating dock would be connected to the lakeshore via a pedestrian ramp. The slip structures and dock would be held in place by concrete anchors set on the bottom of Lake Berryessa, with stainless steel cables connecting the facilities to the anchors.

**Regulatory Process:** Project implementation will require the Central Valley Water Board to take regulatory action through the issuance of a Clean Water Act section 401 Water Quality Certification. This notice serves as a notice of intent to adopt a negative declaration for this project pursuant to CEQA Guidelines section 15072.
