Amendment to the Water Quality Control Plan for the Tulare Lake Basin, to Remove the Municipal and Domestic Supply (MUN) and Agricultural Supply (AGR) Beneficial Uses from Groundwater Within a Designated Horizontal and Vertical Area Within and Surrounding the Administrative Boundaries of the South Belridge, Monument Junction, and Cymric Oil Fields in Kern County Near McKittrick, California

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) is proposing an amendment to the Water Quality Control Plan for the Tulare Lake Basin (Basin Plan) to remove the Municipal and Domestic Supply (MUN) and Agricultural Supply (AGR) as beneficial uses of groundwater within a designated horizontal and vertical area in Kern County near the unincorporated community of McKittrick, California (proposed Basin Plan Amendment). The horizontal and vertical de-designation area is located within and surrounding the administrative boundaries of the South Belridge, Monument Junction, and Cymric Oil Fields (Proposed De-designation Zone). The proposed Basin Plan Amendment will have no effect on existing beneficial uses outside of the Proposed Dedesignation Zone.

Draft Staff Report for Public Comment

The Central Valley Water Board's Basin Planning Program is a certified regulatory program exempt from the California Environmental Quality Act (CEQA) requirement

to prepare an environmental impact report. (Public Resource Code, section 21080.5; California Code Regulations, title 14, section 15251(g)). In accordance with applicable State Water Resources Control Board-promulgated regulations (Cal. Code Regs., tit. 23, § 6775 et seq.), the Draft Staff Report supporting the proposed Basin Plan Amendment constitutes the Substitute Environmental Document (SED).² The Draft Staff Report contains, among other things, an analysis of potential environmental impacts associated with the proposed Basin Plan Amendment. Notably, Central Valley Water Board staff have determined that the proposed Basin Plan Amendment will not result in any potential significant environmental impacts. Additionally, an External Peer Review of the scientific conclusions of the Draft Staff Report was conducted and the staff report includes a response to the peer review comments.

The Draft Staff Report also includes the language that is proposed to be amended into the Basin Plan, and the proposed location of that language in the Basin Plan.

The Draft Staff Report and External Peer Review have been posted on the Central Valley Water Board's webpage for the McKittrick Area Oil Fields Beneficial Use Evaluation Basin Plan Amendment

All written comments on the Proposed Basin Plan Amendment and supporting Draft Staff Report must be received no later than the above deadline, though untimely submittals may be accepted for good cause at the Board Chair's discretion. Unless accepted for good cause, untimely written comments will be excluded from the administrative record. (See Cal. Code Regs., tit. 23, § 3779, subd. (b).)

This Notice additionally serves as the "Notice of Filing" for purposes of California Code of Regulations, title 23, section 3779, subdivision (a).

Public Hearing on Basin Plan Amendment

The Central Valley Water Board has scheduled a hearing to receive oral comments on, and consider adoption of, the Proposed Basin Plan Amendment and the supporting Final Staff Report (SED). The hearing will take place at the date, time and place below:

Prior to the hearing, Central Valley Water Board staff will prepare a Final Staff Report that includes responses to timely written comments. The Proposed Basin Plan Amendment may also be revised based on input received during the comment period.

At the hearing, the Central Valley Water Board will provide members of the public, interested parties, and representatives of other agencies the opportunity to present oral comments on the Proposed Basin Plan Amendment and the Final Staff Report (SED). The Central Valley Water Board will consider all timely comments concerning the Proposed Basin Plan Amendment and Draft/Final Staff Report, along with any Central Valley Water Board staff responses to written comments on the Draft Staff Report.

Oral comments at the hearing need not be limited in scope to those issues already raised during the public comment period. (Cal. Code Regs., tit. 23, § 3779, subd. (c).) However, comments/presentations will be limited to three minutes, subject to extensions at the discretion of the Central Valley Water Board Chair. If a group will require more than three minutes, the group is strongly encouraged to designate a spokesperson and

All exhibits presented at the hearings, including charts, graphs, and other testimony, must be left with the Central Valley Water Board and will become part of the administrative record for the Proposed Basin Plan Amendment.

The entire public file for the Proposed Basin Plan Amendment, including the Draft Staff Report and all appendices thereto, shall be available for inspection at the Central Valley Water Board's office in Rancho Cordova (address above).
