Dear CRLA et al., CWC et al., and Sustainable Conservation:

Thank you for your comments regarding the Priority 1 Management Zone Implementation Plans (MZIPs) for the Central Valley Water Board Nitrate Control Program. The MZIPs were due on 5 September 2023 and the public review period extended from 1 November 2023 through 22 December 2023. Four comment letters were received on 22 December 2023. Both CWC et al. and Sustainable Conservation each submitted one comment letter to the Central Valley Water Board. CRLA et al. submitted two comment letters regarding the Kings Water Alliance and Valley Water Collaborative (Modesto and Turlock Management Zones).

The Central Valley Water Board has prepared a document responding to the written comments in your letters.
