The collection, preservation and holding times of all samples shall be in accordance with U. S. Environmental Protection Agency approved procedures. All analyses shall be conducted by a laboratory certified by the State Department of Health Services to perform the required analyses

REPORTING

1. Quarterly monitoring reports shall be submitted to the Regional Water Board by January 15, April 15, July 15, and October 15 of each year to:



 The discharger shall arrange the data in tabular form so that the specified information is readily discernible. The data shall be summarized in such a manner as to clearly illustrate whether the facility is operating in compliance with the waste discharge requirements.

- 3. Report immediately any failure in the waste disposal system to the Regional Water Board's Executive Officer and the Director of the County Environmental Health Department by telephone with follow-up by letter.
- 4. Note any changes in the disposal systems for the quarter.
- 5. Each report shall contain the following statement:


