RECISSION OF WASTE DISCHARGE REQUIREMENTS ORDER R7-2012-0003

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board), hereby makes the following Findings:

- 1. Order R7-2012-0003 regulates discharges from Wal-Mart Stores, Inc. (Discharger), as the owner/operator of the Store 1915-04 Wastewater Treatment Plant (WWTP) located at 58501 Twentynine Palms Highway, Yucca Valley, California, 92284.
- 2. The WWTP consisted of a Fixed Activated Sludge Treatment system that was installed in buried tanks. The entire WWTP was buried, except for the power and controls equipment, chemical feed systems, and blowers. Treated effluent from the WWTP was then delivered to twelve on-site, circular seepage pits. The WWTP was permitted to discharge a 30-day average of 16,000 gallons per day of treated domestic wastewater.
- 3. In a letter dated April 16, 2021, the Discharger requested that Order R7-2012-0003 be terminated, stating that the WWTP connected to Hi-Desert Water District's (HDWD) centralized sewage system as of May 21, 2020 and that the WWTP was demolished as of January 14, 2021.
- 4. Because the WWTP no longer exists and connection has been made to HDWD's centralized sewage system, the recission of Order R7-2012-0003 is appropriate.
- 5. The Regional Water Board, in a public meeting, heard and considered all comments pertaining to the proposed rescission of the Order 2012-0003.

IT IS HEREBY ORDERED, the following Order, containing Waste Discharge Requirements, be rescinded:
