The Executive Officer (EO) of the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) hereby provides the following report on recent staff activities for July and August 2023 in the region:

1. LAND DISPOSAL - WASTE DISCHARGE REQUIREMENTS PROGRAM

New River Sampling: During the months of July and August 2023, the Land Disposal Unit coordinated the New River Sampling Program by preparing sample bottles, coordinating lab contracts, and assisted in record keeping. During the months of July and August, Regional Water Board staff of the National Pollutant Discharge and Elimination System/Stormwater Unit and the Site Cleanup Unit collected water quality samples at the New River (International Boundary). Imperial County [*Julya Mestas*].

Permitted Facility Inspections: During the months of July and August 2023, the Land Disposal Unit conducted three (3) Complaint and Oversight inspections of Facilities regulated by Waste Discharge Requirements. The following Facilities were inspected:

Notices of Violation: Six (6) Notices of Violation (NOV) were issued to Dischargers for violations of Waste Discharge Requirements and the California Water Code.

3. UNDERGROUND STORAGE TANK AND SITE CLEANUP PROGRAM

Regional Water Board staff continues to work with staff from the Department of Defense (DoD) to expedite ongoing activities at cleanup sites located at military facilities within the Colorado River Basin Region. The UST and SCP staff issued correspondence reviewing technical reports, requesting site access, providing direction for site assessment, and approving remedial action plans for sites currently in the assessment and cleanup process. 4. NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PROGRAM

Notice of Applicability (NOA) for Low Threat Discharges to Surface Waters within The Colorado River Basin Region, New River Improvement Project, Imperial County

On July 20, 2023, the Executive Officer (EO) issued a Notice of Applicability (NOA) for Low Threat Discharges to Surface Waters within the Colorado River Basin Region General Order R7-2015-0006 (Order) for the New River Improvement Project. The proposed discharge consists of wastewater resulting from dewatering activities from the installation of the New River Improvement Project Calexico Reach's Trash Screen and Diversion Structure, the Pump-back system's pump station, and the 72-in bypass pipe. The quality of the proposed dewatering wastewater has been evaluated by staff and meets all screening levels required in the Order. The NOA conditionally authorizes the City of Calexico to discharge low threat wastewater with additional monitoring as described in the Notice of Intent (NOI) and in accordance with the requirements of the Order. Amended Time Schedule Order (TSO) R7-2020-0019-1, Issued to Imperial Irrigation District, El Centro Generating Station, Imperial County

On August 31, 2023, an amendment to Time Schedule Order (TSO) No. R7-2020-0019 for the Imperial Irrigation District's El Centro Generating Station was approved. Amended TSO No. R7-2020-0019-1, extends the deadlines for two interim milestones established in the original Time Schedule Order. The deadline for the milestone, "Obtain construction approval of project", has been extended from August 31, 2023, to March 31, 2024. The deadline for the milestone, "Complete the Pollution Prevention Plan and construction of the project", has been extended from December 31, 2024, March 1, 2025. The final milestone, which includes coming into full compliance with Order R7-2020-0006, has not been extended and remains at April 1 2025. [Fatima Alrahem, WRCE; Logan Raub, SES]
