**AMENDMENT OF 401 WATER QUALITY CERTIFICATION AND ORDER FOR
1C08U INTERSTATE 10 BLYTHE PAVEMENT REHABILITATION PROJECT
[FORMERLY "1C083"], WDID NO. 7B333037001**

Dear Mr. Compton:

On May 23, 2022, the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) received a request to amend the California Department of Transportation's (Caltrans) Clean Water Act (CWA) section 401 Water Quality Certification and Order (Order) for a project originally identified as the "1C083 Interstate 10 Blythe Pavement Rehabilitation Project" (Project). The Project, which is located in the County of Riverside, was originally certified on May 20, 2022.

For purposes of consistency with its own internal tracking system, Caltrans has requested that the prefix of the Project name (as stated in the Order) be changed from **1C083** to **1C08U**. There are no other changes to the certified Project; the Project description and the Order's requirements are completely unchanged.
