Expert Panel & Timeline

- AB 574 requires that an expert review panel review the proposed criteria and adopt a finding as to whether, in its expert opinion, the proposed criteria would adequately protect public health.
- Expert Panel convened in July 2021
- Expert Panel meetings held:
 - August 2021
 - December 2021
 - January 2022
 - February 2022
- Expert Panel finding to be presented in a consensus memo
 - Expert Panel consensus draft memo March 2022
 - Expert Panel consensus final memo April 2022



Improve Public Health Protection

- Panel recommendations that will improve public health protection:
 - A requirement for 24/7 operation for at least 12 months before considering a request for reducing the number of operators and/or unstaffed operations
 - A requirement for third-party peer review for:
 - Review DPR treatment plant designs, including instrumentation, controls, and SCADA system
 - Review project at commissioning
 - Review project during operations for continuous improvement to implement engineering best practices
 - A requirement for online nitrite monitoring for the ozone-BAC treatment

Improve Clarity of the Proposed Criteria

- Panel recommendations that will improve the clarity of the language in the proposed criteria:
 - Requirement for additional topics to be included in an Engineering Report, including:
 - describing optimization of upstream wastewater treatment to produce a stable and high-quality, fully nitrified water as the feed water to a DPR advanced treatment facility, and
 - consideration of temperature effects on treatment and distribution system chemistry.
 - Ozone/BAC treatment process requirements
 - Recommendations highlighting the importance of addressing the lifecycle planning horizon in the Joint Plan, cybersecurity planning in the Engineering Report, and communication and public notification

- Receive Expert Panel findings in a consensus memo
- Develop regulatory package (2022)
 - Informative Digest
 - Initial Statement of Reasons
 - Regulation Text
 - Fiscal Impacts
- Enter regular rulemaking process (2023)
 - Publish Notice of Proposed Action
 - Public comment period
 - Public hearing
 - Board adoption & CEQA

If deadline beyond 18 months is needed, consult with June 30, 2024 expert review panel and post findings per CWC 13561.2(a)(5) process
