**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT,  
PUBLIC WORKSHOP, AND BOARD HEARING**

**PROPOSED DEFINITION OF  
MICROPLASTICS IN DRINKING WATER**

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board) will receive public comments on the draft Definition of Microplastics in Drinking Water (hereafter Definition). Written comments must be received by **12:00 noon on Friday, April 24, 2020**. For additional information regarding submitting comments, please read below under “Submission of Written Comments.”

**NOTICE IS ADDITIONALLY HEREBY GIVEN** that the State Water Board will hold a workshop at the time and place described below to receive information and solicit public input regarding the draft Definition. This is an informal stakeholder meeting where a quorum of the State Water Board may be present, but the Board will take no formal action. The workshop will begin with a staff presentation summarizing the draft Definition, followed by an opportunity for oral and written public comments. State Water Board staff will answer questions related to the draft Definition.

## **BACKGROUND**

The California Safe Drinking Water Act requires the State Water Board to administer provisions relating to the regulation of drinking water to protect public health, including, but not limited to, conducting research, studies, and demonstration programs relating to the provision of a dependable, safe supply of drinking water, enforcing the federal Safe Drinking Water Act, adopting implementing regulations, and conducting studies and investigations to assess the quality of water in private domestic water supplies. Under the act, the implementing regulations are required to include, but are not limited to, monitoring of contaminants and requirements for notifying the public of the quality of the water delivered to customers.

In 2018, Senate Bill 1422 added section 116376 to the Health and Safety Code, requiring the State Water Board, on or before July 1, 2020, to adopt a definition of microplastics in drinking water. Section 116376 further requires the State Water Board no later than July 1, 2021, to (1) adopt a standard methodology to be used in the testing of drinking water for microplastics; (2) adopt requirements for four years of testing and reporting of microplastics in drinking water, including public disclosure of those results; (3) if appropriate, consider issuing a notification level or other guidance to aid consumer interpretations of the results of the testing required pursuant to this section; and (4) accredit qualified laboratories in California to analyze microplastics. This statute permits the State Water Board to implement this section through the adoption of a policy handbook that is not subject to the regular rulemaking requirements of the Administrative Procedure Act.

Staff intend to present a draft Definition of Microplastics in Drinking Water to the State Water Board for consideration at the Board's June 16, 2020 meeting.

## **SUBMISSION OF WRITTEN COMMENTS**

Any interested person, or their representative, may submit written comments relevant to the proposed definition to the Clerk to the State Water Board. Any written comments pertaining to this definition, regardless of the method of transmittal, must be received by the Clerk to the State Water Board by **12 noon on Friday, April 24, 2020**. Comments received after this date will not be considered timely. Persons wishing to use the California Relay Service may do so at no cost by dialing 711.

The State Water Board requests but does not require that, if reports or articles in excess of 25 pages are submitted in conjunction with the comments, the commentator provide a summary of the report or article and describe the reason for which the report or article is being submitted or is relevant to the proposed definition.

All comments, including email or fax transmissions, should include the author’s name and U.S. Postal Service mailing address in order for the State Water Board to provide copies of any notices for proposed changes to the regulation text on which additional comments may be solicited.

Please note that under the California Public Records Act (Gov. Code, §6250 et seq.), your written and oral comments, attachments, and associated contact information (e.g., your address, phone, email, etc.) become part of the public record and can be released to the public upon request.

Written comments will not be available until after the comment deadline.


