Potential Consolidation of Magnolia Mutual Water with Sacramento County Water Agency

The State Water Resources Control Board (State Water Board) invites you to attend a public meeting to learn about the potential consolidation of Magnolia Mutual Water with Sacramento County Water Agency.

BACKGROUND

Magnolia Mutual Water has a long history of violations of the arsenic maximum contaminant level and has been issued multiple compliance orders by the Sacramento County Environmental Management Department dating back to 2008. Due to these ongoing compliance issues, the State Water Resources Control Board is initiating the mandatory consolidation process between Magnolia Mutual Water and the Sacramento County Water Agency. This process includes an initial 6-month period during which the two water systems may attempt to negotiate a voluntary consolidation. The State Water Board will host two public meetings during this period. This meeting is the first public meeting in the consolidation process. Its purpose is to inform customers about the potential consolidation and to provide an opportunity for public comment.
