**Potential Consolidation of Foothill Mutual Water Company  
with the City of Morgan Hill**

The State Water Resources Control Board (State Water Board) invites you to attend a public meeting to learn about the potential consolidation of Foothill Mutual Water Company with the City of Morgan Hill.

**BACKGROUND**

Foothill Mutual Water Company has a history of violations of the nitrate maximum contaminant level and has been issued multiple compliance orders by the Division of Drinking Water Santa Rosa District dating back to 2004. Due to these ongoing compliance issues, the State Water Resources Control Board is initiating the mandatory consolidation process between Foothill Mutual Water Company and the City of Morgan Hill. This process includes an initial 6-month period during which the two water systems may attempt to negotiate a voluntary consolidation. The State Water Board will host two public meetings during this period. This meeting is the first public meeting in the consolidation process. Its purpose is to inform customers about the potential consolidation and to provide an opportunity for public comment.
