**PROPOSITION 84, SECTION 75022 - Third Round Project Priority List
Small Community Infrastructure Improvements for Chemical and Nitrate Contaminants**

The California Department of Public Health is pleased to announce the posting of the Proposition 84, Section 75022, Round 3 Project Priority List (PPL). This list is a compilation of eligible projects from the Round 1 and Round 2 Project Priority Lists that were not invited to apply for funding or were bypassed during the previous funding rounds. This list also includes projects that had Universal Pre-applications submitted in 2009 and 2010.

In order ensure consistency with our ranking process, the projects on the list have been assigned ranking points that are consistent with the procedures specified in the Proposition 84 Final Revised Criteria, which was adopted on October 20, 2010, after extensive stakeholder reviews and public comment.

We would like to thank everyone who submitted comments during the Proposition 84 Draft Round 3 PPL 30-day public comment period that opened on February 11, 2011, and closed on March 14, 2011. The additional information you provided during the public comment period has been carefully reviewed and any necessary changes have been made to the final Round 3 PPL. Your involvement during the public comment process has helped ensure the accuracy of the Round 3 PPL.

Invitations to apply for Proposition 84, Section 75022, Grant Funding

The California Department of Public Health is pleased to announce that projects with seventeen (17) or more ranking points were sent invitation letters that include Notice of Intent forms. Invited water systems intending to apply for Proposition 84, Section 75022, funding must state their intent on the NOI form and **return it to CDPH by May 31, 2011**. Failure to return the NOI by the specified deadline will result in the project being bypassed.

Invitations to apply for funding do not constitute a commitment of funds. Invitations are sent to solicit full applications for projects that may be eligible for funding. The submitted applications must be evaluated to determine if the project is eligible to receive a funding agreement. Projects determined to be ineligible to receive a funding agreement will be bypassed.

Please note that Proposition 84, Section 75022, grant funding is limited and invited projects that do not provide the documents necessary to process their applications may not receive funding. If Proposition 84, Section 75022, grant funding is not available when the project is ready to enter into a funding agreement, CDPH will evaluate the project for funding under the Safe Drinking Water State Revolving Fund program.
