Applicants that do not submit a NOI form by the deadline will not be considered for funding.

After submitting a NOI, please fill out and return a complete application by **August 31, 2011**. Applications received after this deadline will not be processed and the project will not be considered for funding.

### **Submitting the Completed Application**

Two (2) application packages, excluding plans and specifications, must be submitted to:

One (1) application package, including plans and specifications, must be submitted to the CDPH District Office that has jurisdiction over your county.

Applications received by the deadline will be reviewed and ranked based on the Proposition 84, Section 75025 Ranking Criteria for Projects, adopted on September 17, 2009. A Round 2 Project Priority List (PPL) will be established using the procedures stated in the criteria. Fundable projects will be identified and notifications will be sent to eligible applicants after the final PPL is posted. We are anticipating that a total of approximately \$15 million dollars will be available to fund projects. Any funding offers will be subject to availability of funds.
