ORDER IMPOSING CONDITIONAL WATER RIGHT CURTAILMENT AND REQUIRING REPORTING IN THE SHASTA RIVER WATERSHED (ORDER WR 2024-0006-DWR)

This letter and the enclosed Order contain important information regarding the curtailment of the water right(s) listed in Attachment A (at the end of the Order), that are owned by «PRIMARY_OWNER_NAME» or their successor in interest. Depending on the water right(s) you hold, Attachment A may include permits and licenses issued after the date of the Shasta Adjudication, and/or appropriative groundwater rights associated with a specific groundwater well or assessor's parcel number (APN). This letter also describes a certification (online form) that you or your agent of record, are required to submit by June 17, 2024. You will need the Login(s)/Water Right Identification Number(s) and Password(s)/Reporting Identifier(s) in Attachment A² to complete the required forms.

The State Water Board Resources Control Board (State Water Board) adopted an emergency regulation establishing emergency minimum flows in the Scott River and Shasta River watersheds. (Cal. Code Regs., tit. 23, §§ 875-875.9.) The regulation went into effect on February 1, 2024, and will remain in effect for one year. The emergency regulation is available online.³ A similar prior emergency regulation expired on

July 31, 2023. The current emergency regulation re-establishes minimum flow requirements and requires curtailment of diversions, when necessary, to meet those flows. Flows at the United States Geological Survey (USGS) Yreka gage have been higher than the emergency minimum flows since February 1, 2024, when the regulation went into effect. However, flows have been generally decreasing since May 5, 2024, and have included significant fluctuation. With higher temperatures and minimal precipitation forecasted in the watershed, diversions are expected to increase over the coming weeks to meet heightened irrigation demands, increasing the risk of flows falling below the emergency minimum flow requirements.

The enclosed Order establishes and details the following requirements:

- Required reporting on receipt of and compliance with the Order (Curtailment Certification);
- Coordination on diversion timing and amounts;
- Curtails certain surface water and appropriative groundwater diversions in order of water right priority only if coordination alone fails to maintain minimum instream flow requirements; and
- Describes exceptions to curtailments and reporting (certifications or petitions) that must be completed for limited uses (i.e., minimum human health and safety needs, livestock needs, non-consumptive instream uses).

You or your agent of record are responsible for immediately notifying all parties that divert water under the water right(s) identified in Attachment A of the enclosed Order and its requirements.

How Conditional Curtailments Work

The State Water Board is issuing an Order imposing conditional water right curtailments for the Shasta River watershed. Conditional curtailments provide flexibility for diverters to continue coordinated diversions to best meet the needs of all parties in the watershed while also providing assurances that the minimum emergency flow requirements will be met and sustained. Conditional curtailment provides for the cessation of diversions in order of water right priority if diverters are unable to maintain the flows through coordinated diversions. If coordination alone is not enough, the diverters must stop diverting until water supply conditions improve and there is no longer a risk to maintaining the minimum flow requirements, to water supplies for minimum human health and safety needs (including firefighting), to minimum livestock needs, or for injury to senior diverters. Curtailed diversions may re-initiate upon notification that water is again available.

The State Water Board will provide all future updates to curtailments (when suspended, reinstated, or rescinded) on the State Water Board's Scott River and Shasta River Watersheds Emergency Regulation webpage⁴ and through emails sent out to individuals that have signed up for the "Scott-Shasta Drought" Email Subscription List

under "Water Rights". ⁵ Signing up for this email list is the best way to stay informed about implementation of the regulation, including changes to curtailments. All water users are highly encouraged to sign up for the list.

Groundwater Wells

The emergency regulation applies to water rights for diversions of surface water as well as appropriative and overlying groundwater extractions because of the interconnection of surface water and groundwater in the Shasta River watershed. Overlying groundwater rights are generally senior and attach to land overlying a groundwater basin. Overlying groundwater rights are not impacted by this curtailment order. Appropriative groundwater rights, which are impacted by this curtailment order, are the type of water right you have if you pump water but: (1) do not own (or rent or lease) land overlying the basin that you use the water on; (2) own overlying land but use the water on non-overlying land; or (3) sell or distribute⁶ the water to someone else. The priority date for an appropriative groundwater right is the date when the groundwater well was constructed and water was first used for a non-overlying use.

In the Shasta River watershed, appropriative groundwater pumpers are generally more junior to many surface water diversions, including those described in the Shasta Adjudication. Groundwater diversion curtailment extends only to appropriative groundwater uses established on or after November 25, 1912.⁷ If you divert water at a groundwater well, and that water is used for both overlying and appropriative uses, then only the appropriative use is conditionally curtailed. Selling groundwater to be hauled and used at a different location is an appropriative use and is subject to conditional curtailment if the appropriative use started on or after November 25, 1912.

Allowances for Continued Limited Diversions

The regulation has exceptions for certain types of limited diversions that may continue even when flows are low and curtailment would be required at your priority, if the appropriate form(s) is submitted to the State Water Board (see more on this below). These exceptions are:

- <u>Non-consumptive Diversions</u>. This exception applies if your diversion is not consumptive, meaning that it does not use up water or change the time the water is available to others (i.e., diversions do not decrease stream flows).
- <u>Minimum Human Health and Safety Diversions</u>. This exception applies if a curtailed diversion is your only water source for minimum human health and safety purposes, like drinking, cooking, washing, or meeting the state's critical

- infrastructure needs. Please note that diversions for firefighting may continue under this exception.
- <u>Minimum Livestock Watering Diversions</u>. This exception applies if a curtailed diversion is your only source for minimum livestock watering needs. See section 875.3 in the <u>Emergency Regulation</u> for more information on minimum livestock watering.

If you want to continue diverting using one of the above exceptions, you must submit additional information to the State Water Board using the applicable form(s) available at: https://public.waterboards.ca.gov/WRInfo.

Required Response - Curtailment Certification Form

Within 10 calendar days of issuance of this curtailment order, all water right holders or their agents receiving this Order are required to submit a Shasta Curtailment Certification Form. The online Shasta Curtailment Certification Form must be filled out to acknowledge your water right has been conditionally curtailed and you will begin coordinating your diversions with the watermaster to help keep flows above the required minimum instream flow. If coordination is not enough to maintain flows above the minimum flow requirement you will cease diverting until stream conditions improve. You may also confirm whether you are pursuing an exception to continue limited diversions under the curtailment order as detailed above. Timely and accurate completion of the form can help you avoid unnecessary enforcement proceedings. Your Login(s)/Water Rights ID and Password(s)/Water Right Identifier(s) are provided in Attachment A of the enclosed Order. You can access and complete the form online at: https://public.waterboards.ca.gov/WRInfo.

Staff are available to answer questions or otherwise assist with completing the form. (See the Questions section below for contact information.)

Potential Enforcement

The enclosed Order includes enforceable requirements regarding a water right or claim of right that require your immediate attention. Diverting water in violation of the enclosed Order or the regulation risks administrative fines, a cease-and-desist order, or prosecution in court. The State Water Board has enforcement discretion. Decisions related to enforcement and associated penalties are based on the specific circumstances of the violation. Fines may be up to \$1,000 per day of violation. (Wat. Code, §§ 1052, 1055, 1846.)

Request for Reconsideration

You may submit a petition within 30 days to request that the State Water Board reconsider the enclosed Order. The process and grounds for reconsideration are provided by California Code of Regulations, title 23, sections 768 through 771. To ensure timely consideration, any petition for reconsideration should be emailed to: ScottShastaDrought@waterboards.ca.gov.

ORDER IMPOSING CONDITIONAL WATER RIGHT CURTAILMENT AND REQUIRING REPORTING IN THE SHASTA RIVER WATERSHED ISSUED JUNE 7, 2024

FINDINGS:

1. On December 19, 2023, the State Water Resources Control Board (State Water Board or Board) adopted an emergency regulation, titled Establishment of Minimum Instream Flow Requirements, Curtailment Authority, and Information Order Authority in the Scott River and Shasta River Watersheds (hereinafter "Regulation"). The Regulation establishes minimum instream flow requirements, minimum livestockwatering efficiency limits, curtailment authority, and information order authority in the Scott River and Shasta River watersheds. State Water Board Resolution No. 2023-0047¹, adopted the Regulation. State Water Board Resolution No. 2023-0047 and the Board's Findings of Emergency and Informative Digest², dated January 2024 describe the need for the Regulation and its intent. State Water Board Resolution No. 2023-0047 and the Findings of Emergency and Informative Digest are incorporated by reference into this order. The Regulation went into effect on February 1, 2024, when it was approved by the Office of Administrative Law and filed with the Secretary of State. The Regulation establishes minimum instream flow for Shasta River, as measured in cubic feet per second (cfs) at United States Geological Survey gage no. 11517500 located near Yreka (USGS Yreka gage), as:

The Regulation includes California Code of Regulations, title 23, sections 875, 875.1, 875.2, 875.3, 875.5, 875.6, 875.7, 875.8, and 875.9, which establish the circumstances under which the State Water Board may issue curtailments in the Shasta River watershed to maintain minimum flows for fish, as well as exceptions to curtailments and curtailment reporting requirements.

- 2. After a slightly above-average snowpack this year, the Shasta River watershed received below average precipitation throughout May. Since May 5, 2024, flows have been declining in the Shasta River at the USGS Yreka gage. Additionally, no significant snow cover remains in the Shasta River watershed as of May 31, 2024. With the snowpack gone, no forecasted precipitation, and air temperatures forecast to increase in the Shasta River watershed, flows are expected to continue an overall decreasing trend and are anticipated to approach or fall below the minimum flow requirement absent curtailment or significant coordination of diversions.
- 3. All historical hydrographs in the past 25 years (after year 2000) that have an April snow budget similar to this year's (including 2003, 2004, 2005, 2008, 2010, 2012, 2016, and 2021) show flows will drop below the minimum flow requirement in the time period between June 14 July 10 (except 2021, when flows dropped below the minimum flow requirements in April). This ensemble of similar snowpack years and the historical experience of flows dropping below the minimum flow requirement indicate that the minimum flows will not be met throughout the summer without coordination and potentially the need for curtailment if coordination efforts prove insufficient to meet and sustain the emergency minimum flow requirements at the USGS Yreka gage.
- 4. Historically, diversions increase, and flows decrease throughout the irrigation season. Minimum summer flows in similar snowpack years have ranged from 7 to 41 cfs, which is between 9 to 43 cfs short of the 50 cfs minimum flow requirement at the USGS Yreka gage applicable from May 1 through September 15 in the Shasta River watershed.
- 5. Gage data since the general onset of the irrigation season on April 1, shows multiple instances of rapid flow fluctuations of up to 20 cfs at the USGS Yreka gage, occurring in the absence of precipitation.
- 6. As of noon on June 6, 2024, flow at the USGS Yreka gage was 71.4 cfs, which is 21.4 cfs greater than the current minimum flow requirement of 50 cfs for May September 15.
- 7. Weather forecasts and reports show above average temperatures in Shasta Valley with consecutive days of above average temperatures. Additionally, seasonal forecasting suggests above average temperatures through August. These higher temperatures increase the demand for water, including diversions for livestock watering, irrigation, and emergency needs. Such increased diversions can result in rapid declines in flow as seen historically. Accordingly, as more diversions turn on during the irrigation season and in response to higher temperatures, it is expected

flows in the Shasta River will decrease at a rapid rate without coordination and curtailments, if needed.

- 8. Based on current flow conditions, the fluctuating and decreasing flow curve, historic flows in years with similar hydrology, precipitation and air temperature forecasts, and anticipated water demand, including the information discussed above, the Deputy Director for the Division of Water Rights (Deputy Director) has determined that without curtailment, as described in the Regulation, of diversions with a priority date of or junior to November 25, 1912, flows at the USGS Yreka gage are likely to fall below the minimum flows specified in section 875, subdivision(c)(2)(A) of the Regulation. To ensure that the Regulation's emergency minimum flows are met, it is necessary to conditionally curtail junior water right holders in the Shasta River watershed, described in Section 875.5, subdivision (b)(1)(A) [post-Adjudication appropriative surface water and groundwater rights], as well as a portion of those water right holders in the priority group described in Section 875.5, subdivision (b)(1)(B) [Shasta Adjudication] with priority dates of or junior to November 25, 1912.
- 9. Conditional curtailment provides flexibility for diverters to continue coordinated diversions to best meet the needs of all parties in the watershed while also providing assurances that the minimum emergency flow requirements will be met and sustained through the cessation of diversions in order of water right priority if diverters are unable to maintain the flows through coordinated diversions. Coordinated diversion may not be sufficient due to increased irrigation demand as temperatures rise or other factors that result in demands that do not support attainment of the emergency minimum flow requirements.
- 10. Flows in the Shasta River watershed can decline sharply over a short period of time with the general onset of the irrigation season as seen in April 2014, 2020, and 2021, and throughout the following irrigation seasons. Curtailment of water rights in advance of when flows drop below the emergency minimum flow requirement may be necessary to help ensure such declines do not result in flows below the emergency minimum flow requirement. Flow trends in upstream gages (SPU and Montague) can assist in evaluating whether a rapid flow drop is anticipated at the USGS Yreka gage, as can information regarding ongoing and immediately anticipated diversions. The ability to immediately curtail the most junior water rights when the USGS Yreka gage flows near the minimum flow requirement, but in advance of flows dropping below the requirement, will help ensure the emergency minimum flow is maintained and will allow more time for enhanced coordination among more senior conditionally curtailed water rights and/or the further curtailment of these conditionally curtailed water rights to support meeting and sustaining the emergency minimum flow requirement at the USGS Yreka gage.
- 11. Providing for expedited curtailment of water rights up to and including a priority date of January 1, 1958, is estimated to affect at least 30 cfs of diversions, including all of the known groundwater appropriations for which the effect on the surface water flows is more indirect than surface water appropriations, for which diversion amounts are not reported, and which are not included in Watermaster services. Requiring

these most junior diverters to confirm that curtailment is not required prior to initiating or continuing diversion when flows are lowered to 5 cfs above the minimum instream flow or lower at the USGS Yreka gage is an appropriate condition in light of the historic, current, and anticipated hydrologic conditions.

- 12. Requiring conditional curtailment to a priority date of November 25, 1912, includes more than 70 cfs face value of surface water rights, with the most senior right accounting for 42 cfs. Coordination across a group this large is likely to significantly extend the ability to meet or exceed the emergency minimum flow requirement (currently 50 cfs at the USGS Yreka gage). Additionally, curtailment of all or part of the rights in this group would provide significant additional flows to the Shasta River that would address the shortfalls seen in prior years with similar snowpack.
- 13. Flows will respond to various factors including precipitation, snowmelt, and contributions from the curtailments. Ongoing assessment of water supply and demand projections will be used to manage curtailments. The Deputy Director may suspend or rescind curtailments in the order of priority, as warranted by changing conditions.
- 14. The State Water Board will provide all future updates to curtailments (e.g., the status of curtailment, including when suspended, reinstated, or rescinded) on the State Water Board's Scott River and Shasta River Watersheds Emergency Regulation webpage³ and through emails sent out to individuals that have signed up for the "Scott-Shasta Drought" Email Subscription List under "Water Rights" ⁴. Signing up for this email list is the best way for those subject to this curtailment order to stay informed about implementation of the regulation, including changes to curtailments.

IT IS HEREBY ORDERED:

- 1. This curtailment order shall be effective on June 8, 2024.
- 2. Diversion of water in the Shasta River watershed pursuant to the water right(s) listed in Attachment A are "conditionally curtailed" effective June 8, 2024, or upon delivery of this Order, whichever is later. If the minimum flow requirement cannot be sustained at the USGS Yreka gage through coordinated diversions, diversions must cease in order of water right priority and may be permitted to continue only if authorized under an exception to curtailment as described by sections 875.1, 875.2, and/or 875.3 of the Regulation.
- 3. Diversions of water in the Shasta River watershed pursuant to the water right(s) listed in Attachment A are directed to immediately work with either the Scott Valley and Shasta Valley Watermaster District (Watermaster) or the State Water Board on coordinating diversions. Coordination with the Watermaster is encouraged, but for rights not subject to Watermaster authority, coordination may be with the State

Water Board. Coordinating diversions entails providing anticipated water needs to the Watermaster or State Water Board, on a weekly basis (or more frequently if requested) and engaging with the Watermaster or State Water Board to align the timing and amounts of water diverted to avoid drops in flow below the minimum emergency flow requirements, while allowing for continued diversions for beneficial use by a larger number of users.

- 4. When flows at the USGS Yreka Gage are at or less than 5 cfs above the emergency minimum flow requirement, water rights diverters with a priority date of or junior to January 1, 1958, as identified in Attachment A, must on a daily basis:
 - (a) Check the Shasta River Watershed mapping tool, accessible via the Scott River and Shasta River Watersheds Emergency Regulation webpage (see footnote 3); or
 - (b) If signed up for the State Water board's "Scott-Shasta Drought" email subscription list, (see footnote 3) check their e-mail prior to initiating or continuing diversion.

If notified on the mapping tool or in an e-mail, the water right diverter must immediately cease diversions. Such notification will be provided if the Deputy Director determines that the emergency minimum flow at the USGS Yreka gage is at risk of not being met or maintained. In making a determination for immediate curtailment, the Deputy Director will consider flow trends at the Montague USGS gage and Department of Water Resources SPU gage and whether information on water supply and demand indicates that coordination will be sufficient to maintain the emergency minimum flow at the USGS Yreka gage. For reference, diverters with a priority of or junior to January 1, 1958, must check daily to determine whether diversion is permissible when the flows, in cfs, are below the numbers in the following table:

- 5. If coordination does not allow for the minimum flow requirement to be met and sustained at the Yreka USGS gage, this diversion under the water rights listed in Attachment A must cease in order of priority to ensure that the required minimum flows are met and sustained at the USGS Yreka gage.
- 6. In accordance with section 875, subdivision (d)(1) of the Regulation, the water rights holder or agent of record who receives this Order is responsible for immediately providing notice of this Order to all diverters exercising the water right(s) listed in Attachment A.
- 7. «PRIMARY_OWNER_NAME» or their agent or successor is required, by June 17, 2024, to submit an online Shasta Water Right Curtailment Certification form (Curtailment Certification) in accordance with section 875.6 subdivision (a) for each water right listed in Attachment A. Attachment A lists the Water Rights ID/Login(s)

- and Password(s)/Water Right Identifier(s) to be used for the required reporting. The Curtailment Certification shall be accessed and completed via the following website link: https://public.waterboards.ca.gov/WRInfo.
- 8. If an exception(s) to curtailment is needed to continue diverting for non-consumptive uses, minimum human health and safety needs, or minimum livestock needs, as authorized by Regulation sections 875.1, 875.2, and 875.3, respectively, «PRIMARY_OWNER_NAME» or their agent or successor shall complete and submit either a self-certification or a petition using the applicable form(s) available at: https://public.waterboards.ca.gov/WRInfo in addition to completing the Curtailment Certification.
- 9. All subsequent modifications to this Order, including curtailment suspensions, reinstatements, rescissions, or other modifications, shall be noticed through electronic means, including through the State Water Board's "Scott-Shasta Drought" email distribution list and will be posted to the State Water Board's Scott River and Shasta River Watersheds Drought Response webpage (https://www.waterboards.ca.gov/drought/scott_shasta_rivers/). «PRIMARY_OWNER_NAME» is responsible for signing up for the "Scott-Shasta Drought" e-mail subscription list and/or for checking the webpage referenced in this paragraph to receive such notice.
- 10. Violation of this Order shall be subject to enforcement and any applicable penalties pursuant to Water Code sections 1052, 1058.5, 1831, 1845, and 1846. To the extent of any conflict between the requirements of this curtailment order and any other applicable orders or conditions of approval, the diverter must comply with the requirements that are most stringent.
- 11. Nothing in this Order is intended to or shall be construed to limit or preclude the State Water Board from exercising its authority under any statute, regulation, ordinance, or other law, including but not limited to, the authority to bring enforcement against diverters for unauthorized diversion or use in violation of Water Code section 1052.

12. Nothing in this Order shall excuse individual water right holders from meeting any more stringent requirements that may be imposed by applicable legally binding legislation, regulations, or a water right permit requirement. This Order does not authorize any act which results in the taking of a threatened, endangered, or candidate species or any act which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish and Game Code sections 2050 to 2097) or the federal Endangered Species Act (16 U.S.C.A sections 1531 to 1544).
