

Subject: Scott River Watershed: Conditional Suspension of Curtailment of Overlying and Adjudicated Groundwater (Addendum 1 to Order WR 2026-0008-DWR)

To: Scott River Water Right Holders (sent to water right holders for which the Board has email addresses and to the Scott-Shasta Drought E-mail List)

PLEASE READ CAREFULLY FOR INFORMATION ON WHO IS AFFECTED AND THE CONDITIONS OF DIVERSION

This addendum conditionally suspends curtailments of overlying and adjudicated groundwater (Priority Group 9) when flows exceed the minimum flow requirements and includes conditions including notification as outlined below. The Scott River and Shasta River Watersheds Drought Emergency Regulation ([Regulation](#)) authorizes the State Water Resources Control Board (State Water Board or Board) to implement curtailments consistent with water rights priorities, as described in the Regulation. Priority Group 9 describes the most senior water rights in the Scott River watershed, and are the diversions covered by [Order WR 2026-0008-DWR](#) (Order). (See Attachment A to this addendum for a list of Priority Group 9 water rights.)

This addendum remains in effect unless modified or replaced by a subsequent addendum.

This addendum does not override ordering paragraph 7 of the Order. **This means that the addendum does not make any changes for parcels covered by a pending or approved groundwater local cooperative solution. If you have an approved or pending groundwater local cooperative solution, you may continue to divert/pump so long as it is in accordance with the conditions of the groundwater local cooperative solution, rather than under the conditions in this addendum.**

Similarly, the addendum does not affect diversions with exceptions from curtailment under the minimum human health and safety, minimum livestock-watering, and non-consumptive use exemptions. Diversions under those exceptions may continue with the limits of the exception rather than under the conditions of this addendum.

All other water rights in the Scott River watershed remain curtailed under other curtailment orders and may not divert unless those orders are amended.

Under this addendum, groundwater pumpers in Priority Group 9 may pump only if all of the following conditions are met:

- **Notify** the State Water Board of the amount of water they plan to divert/pump in advance of starting diversion/pumping, by e-mail to: ScottShastaFlows@waterboards.ca.gov.
- **Check** the flow at the [Fort Jones United States Geological Survey \(USGS\) gage](#) prior to and at least every 12 hours during diversion/pumping.

- **Cease diversions/pumping** when the instantaneous flow at the [Fort Jones USGS gage](#) approaches the minimum flow requirements established in the Regulation (i.e., in the coming months 50 cfs for July, 30 cfs for August, 33 cfs for September). No diversion or pumping shall occur when the flow is at or below the minimum flow requirement.
- **Cease diversions immediately** if directed by the State Water Board.
- **Divert only consistent with their water rights.**

Background:

Following the issuance of [Order WR-2026-0008-DWR](#) on June 10, 2026, flows continued to decline below the June 24-30 minimum flow requirement for the Scott River watershed of 90 cubic feet per second (cfs) to a low flow of 53.4 cfs (as measured at the [Fort Jones USGS gage](#)) around 9:15 pm on June 27, 2026. Following a small precipitation event in the watershed flows slightly increased, reaching 58-59 cfs on June 29-30, 2026, before declining again. As of about 1:30 pm on July 1, 2026, the flow at the Fort Jones USGS gage was 55.3 cfs. Based on flows in excess of the minimum flow requirement for July, the maintenance of flows above 50 cfs, as described above, the limited demand of groundwater users in light of high participation in the groundwater local cooperative solution program, and favorable temperature forecasts, it is appropriate to conditionally suspend Group 9 curtailments for overlying and adjudicated groundwater rights in Attachment A.

While flows are currently above the minimum flow requirement for July, overall flows are anticipated to follow a downward trend at the Fort Jones USGS gage due to insignificant snowpack, water demand, seasonal drought, long-term precipitation and temperature forecasts, and a comparison to flows in recent years with similar snowpack measurements. While the watershed conditions indicate curtailment will be necessary for much of the irrigation season, the State Water Board will continue to monitor flows, flow forecasts, precipitation and temperature forecasts, and watershed conditions regularly to determine if adjustments to the curtailments are appropriate.
