**RESCISSION OF WASTE DISCHARGE REQUIREMENTS
BOARD ORDER NOS. 6-95-37, 6-95-64, 6-86-84, 6-87-115,
AND 6-85-114**

**FOR
MULTIPLE WASTEWATER FACILITIES**

Mono, Inyo, and Los Angeles Counties

The California Regional Water Quality Control Board, Lahontan Region (Water Board) finds:

1. Reason for Action

The Water Board is rescinding the Waste Discharge Requirements (WDRs) for the domestic wastewater discharges at the five facilities listed in Attachment A, which is made part of and attached to this Order. The wastewater discharges at these facilities meet the criteria for enrollment under the State Water Resources Control Board (SWRCB) Order, WQ 2014-0153-DWQ General Waste Discharge Requirements for Small Domestic Wastewater Treatment Systems (General Order). The Water Board intends to issue Notices of Applicability for coverage under the General Order for each facility which would enroll the facility upon rescission of the applicable WDR.

2. Facilities

The five facilities and their respective Board Orders are listed in Attachment A of this Order.

3. California Environmental Quality Act

Rescission of the WDRs is exempt from the provisions of the California Environmental Quality Act (Public Resources Code section 21000, et seq.) in accordance with the California Code of Regulations, title 14, section 15321 (a), Enforcement Actions by Regulatory Agencies.

4. Right to Petition

Any person aggrieved by this Lahontan Water Board action may petition the State Water Board for review in accordance with Water Code section 13320 and California Code of Regulations, title 23, section 2050 et seq. To be timely, the petition must be received by the State Water Board by 5:00 pm on the 30th day

after the date of this Order; if the 30th day falls on a Saturday, Sunday or state holiday, the petition must be received by the State Water Board by 5:00 pm on the next business day. Copies will also be provided upon request.

5. Notification of Interested Parties


The Water Board has notified the dischargers and interested agencies and persons of its intent to rescind the WDRs and has provided them with an opportunity to submit their written views and recommendations.

6. Consideration of Interested Parties

The Water Board, in a public meeting, heard and considered all comments pertaining to the Order.

IT IS HEREBY ORDERED THAT pursuant to the Water Code sections 13260 and 13263, the Board Orders listed in Attachment A are hereby rescinded except for enforcement purposes.
