The California Regional Water Quality Control Board, Lahontan Region (Water Board) finds:

1. Reason for Action

The Water Board has identified the facilities listed in Attachment A that have a change of name and/or ownership since the adoption of waste discharge requirements (Board Orders). These Board Orders need to be revised to show the current name and/or ownership of these facilities.

2. Facilities

The facilities and their respective Board Orders are listed in Attachment A of this Order.

3. California Environmental Quality Act

This action is exempt from provisions of the California Environmental Quality Act (Public Resources Code, Section 21000 et seq) in accordance with California Code of Regulations, title 14, section 15301.

4. Right to Petition

Any person aggrieved by this Lahontan Water Board action may petition the State Water Board for review in accordance with Water Code section 13320 and California Code of Regulations, title 23, section 2050 et seq. To be timely, the petition must be received by the State Water Board by 5:00 pm on the 30th day after the date of this Order; if the 30th day falls on a Saturday, Sunday or state holiday, the petition must be received by the State Water Board by 5:00 pm on the next business day. Copies will also be provided upon request.

5. Notification of Interested Parties

The Water Board has notified the dischargers of its intent to amend the Orders by revising the current name and/or ownership of the facilities.
