NOTICE IS HEREBY GIVEN that the Lahontan Regional Water Quality Control Board (Water Board) will receive public comments on the proposed amendment to the Water Quality Control Plan for the Lahontan Region (Basin Plan) for fecal bacteria water quality objectives (proposed Basin Plan Amendment) and the Technical Staff Report & Substitute Environmental Document for the Amendment (Staff Report).

The proposed Basin Plan amendment involves revisions to narrative bacteria objective and the fecal bacteria water quality objectives of Chapters 3 and 5, and other associated revisions in Chapters 3, 4, and 5 of the Basin Plan.
