CONTINUATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS – SOUTHERN CALIFORNIA WATER COMPANY, COMPTON-DOTY PLANT, 3800 MARINE AVENUE, LAWDALE, CALIFORNIA (NPDES NO. CAG994005, CI-7958)

We have completed our review of your Notice of Intent (NOI) and analytical results of representative groundwater samples submitted in order to continue enrollment under the General NPDES Permit. Discharge of groundwater generated from potable water supply well from the above-referenced facility is currently regulated under NPDES General Permit No. CAG994002 (Order No. 97-043) adopted by this Board on May 12, 1997.

Based on the information provided, we have determined that discharge of groundwater meets the conditions to be regulated under Order No. R4-2003-0108, *General National Pollutant Discharge Elimination System and Waste Discharge Requirements for Discharges of Groundwater from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003. Your existing enrollment under NPDES Permit No. CAG994002, Order No. 97-043, which was issued to you on October 16, 1998, is superseded by this new permit that terminated your coverage under Order No. 97-043.

Enclosed are your Waste Discharge Requirements, which also serve as your NPDES permit, consisting of Order No. R4-2003-0108 and Monitoring and Reporting Program No. CI-7958. Since the groundwater analytical data provided meets the screening criteria, full enrollment under this general permit is authorized and Section E.2. will not be applicable to your discharge. However, the discharge limitations in Part E.1. of Order No. R4-2003-0108 are applicable to your discharge. The groundwater discharge flows into Dominguez Channel. Therefore, the discharge limits in Attachment B of Order No. R4-2003-0108 are not applicable to your discharge.

The Monitoring and Reporting Program requires you to implement the monitoring program on the effective date of coverage under this permit. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-7958 and NPDES No. CAG994005", which will assure that the reports are directed to the
