TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM AND WASTE DISCHARGE REQUIREMENTS—VENTURA COUNTY WATERSHED PROTECTION DISTRICT, SANTA CLARA RIVER GROINS UPGRADE PROJECT, NORTH VENTURA ROAD & 101 FREEWAY, OXNARD, CALIFORNIA (NPDES NO. CAG994004, CI-8927)

The subject discharge is regulated under Order No. R4-2008-0032, *General National Pollutant Discharge Elimination System Permit and Waste Discharge Requirements for Groundwater Discharges from Construction and Project Dewatering to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on June 5, 2008.


We have reviewed your letter dated April 3, 2012, requesting termination of your coverage under the General Permit. The letter indicated that discharge at the above-referenced project has stopped and that the subject NPDES permit is no longer needed.

On June 1, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to surface water. Since there is no discharge of groundwater from the facility, coverage under Board Order R4-2008-0032, General NPDES Permit No. CAG994004, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface waters or land become necessary, you must file a Report of Waste Discharge with this Board and obtain appropriate waste discharge requirements.
