TERMINATION OF COVERAGE UNDER GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT—CITY OF SOUTH GATE—WELL NO. 25, 9021 WEST FRONTAGE ROAD, SOUTH GATE, CALIFORNIA (NPDES NO. CAG994005, CI—9485)

Dear Mr. Torres:

The subject discharge is regulated under Order No. R4-2003-0108, *General NPDES and Waste Discharge Requirements for Groundwater Discharges from Potable Water Supply Wells to Surface Waters in Coastal Watersheds of Los Angeles and Ventura Counties*, adopted by this Board on August 7, 2003.

We have reviewed your November 10, 2011, letter which requested termination of your coverage under the General NPDES permit. The letter indicated that you have completed the well redevelopment project on May 20, 2011. On February 2, 2012, Board staff inspected the project site and verified that there is no discharge of groundwater from the facility to the storm drain. Since there is no discharge of groundwater from the facility, coverage under Board Order No. R4-2003-0108, General NPDES Permit No. CAG994005, for the facility is hereby terminated except for enforcement purposes.

Please note that if future discharges of groundwater to surface water becomes necessary, you must file a Report of Waste Discharge with this office and obtain Waste Discharge Requirements (WDRs) prior to discharging any groundwater from the site to surface waters.
