APPROVAL OF AQUATIC PESTICIDE APPLICATION PLAN UNDER STATEWIDE GENERAL NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PERMIT FOR DISCHARGES OF AQUATIC PESTICIDES TO WATERS OF THE UNITED STATES, (CI-9843, NPDES CAG990005)—CITY OF LONG BEACH

The Los Angeles Regional Water Quality Control Board (Regional Board) has reviewed your Aquatic Pesticide Application Plan (APAP) that you submitted to comply with Order No. 2004-0009-DWQ, Statewide General National Pollutant Discharge Elimination System Permit for the Discharge of Aquatic Pesticides for Aquatic Weed Control in Waters of the United States, adopted by the State Water Resources Control Board (State Board) on May 20, 2004. Based on the information provided, your APAP for using Cutrins Plus-Copper, Aquamaster-Glyphosate, and Reward-Diquat on El Dorado Regional Park Lakes in the City of Long Beach is hereby approved.

In addition to the monitoring and reporting plan (MRP) included in your APAP, you shall conduct annual lake bed sediment monitoring and reporting to evaluate copper concentrations in sediment. When results indicate copper concentrations in sediment at 31.6 ppm or more, you shall conduct concurrent sediment chemistry and toxicity monitoring within 60 days of receipt of the annual sediment chemistry results. In order to monitor copper sediment toxicity, the City of Long Beach should employ the 10-day acute toxicity sediment test using the freshwater amphiod *Hyalella azteca* in accordance with the Surface Water Ambient Monitoring Program (SWAMP) standard protocols.

Please be aware that you are required to submit each calendar year an Annual Report to the Regional Board by March 1 of the following year, as specified in section D.1. and D.2. of Attachment C of the subject NPDES permit. The first Annual Report is due by March 1, 2013. All monitoring reports should be sent to the Regional Board, ATTN: Information Technology Unit. In addition, copy of all monitoring reports should be sent to Jenny Newman, Chief, TMDL Unit 3. When submitting monitoring or technical reports to the Regional Board per these requirements, please include a reference to "Compliance File No. CI-9843 and NPDES No. CAG990005", which will assure that the reports are directed to the appropriate file and staff. Also, please do not combine other reports with your monitoring reports. Submit each type of report as a separate document.
