REVISED TENTATIVE WASTE DISCHARGE REQUIREMENTS – BRANFORD LANDFILL, SUN VALLEY, CALIFORNIA (File No. 56-101)

Dear Mr. Lehman:

On August 4, 2011, we transmitted a tentative Board Order that included tentative waste discharge requirements (WDRs) for the Branford Landfill in Sun Valley, California, to you and informed you that the tentative Order would be considered at our October 6, 2011 Board meeting. However, the tentative Order was not considered at the October Board and, since then, revisions to the tentative WDRs have been made as a result of internal staff discussion. Enclosed is the revised tentative Board Order, which consists of:

1. Tentative requirements, consisting of:
 - a. Waste Discharge Requirements
 - b. Monitoring and Reporting Program (Attachment T)
 - c. Standard Provisions (Attachment W)
 - d. Definitions
2. Publication package, consisting of:
 - a. Public Notice
 - b. Instruction Sheet for Public Notice
 - c. Statement of Posting Notice

In accordance with administrative procedures, this Regional Board, at a public hearing to be held on December 8, 2011, at 9:00 AM, at the Glendale Council Chambers, located at 613 E. Broadway, Glendale, California, 91206, will consider the enclosed tentative Order and comments submitted in writing regarding any or all portions thereof. The Regional Board will hear any testimony pertinent to this discharge and the tentative requirements. It is expected that the Regional Board will take action at the hearing; however, as testimony indicates, the Regional Board at its discretion may order further investigation.

Written comments regarding the tentative Order must be received at the Regional Board office by 5:00 PM on **November 21, 2011**, in order to be evaluated by Board staff and included in the Board's agenda folder. Submittal of written comments by the deadline is required to ensure that all comments are accurately and fully included in the administrative record, that Board staff is able to


provide timely review, and that Regional Board members have sufficient time to give full consideration to the comments and issues raised.
