TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS – CHIQUITA CANYON LANDFILL, CASTAIC, CALIFORNIA (FILE NO. 67-020, CI-6231, GEOTRACKER GLOBAL ID L10003464243)

Dear Mr. Cassulo,

On September 11, 2018, the Los Angeles Regional Water Quality Control Board (Regional Board) sent you and other interested parties the tentative waste discharge requirements (WDRs) (tentative order) for the Chiquita Canyon Landfill in Castaic, California, which is owned and operated by Waste Connections, Inc. The tentative order was scheduled to be considered by the Regional Board at a public hearing on November 8, 2018.

The Regional Board received one comment letter on the tentative order. After considering the comments received and conducting additional internal review of the tentative order, Regional Board staff are proposing some revisions to the tentative order. One proposed revision corrects an administrative finding (Finding No. 47) of the tentative WDRs that mistakenly referenced language indicating that the tentative WDRs were exempt from provisions of the California Environmental Quality Act (CEQA) as an existing facility. The Board is providing a limited, two-week opportunity for public review and comment on this correction and the other changes that have been made. Therefore, the public hearing on the tentative order has been postponed.

Enclosed is a copy of the **revised** tentative WDRs, consisting of:

1. Board Order No. R4-2018-XXXX specifying WDRs,
2. Monitoring and Reporting Program (CI-6231), and
3. Standard Provisions Applicable to Waste Discharge Requirements

All changes made since September 11, 2018, are marked using underlining (for insertions) and strikethrough (for deletions). Also enclosed are the comments received and the Regional Boards response to comments.


In accordance with administrative procedures, this Regional Board will consider the enclosed revised tentative WDRs and comments thereon, at a public hearing to be held at 9:00 AM on **December 13, 2018**, at the City of Simi Valley Council Chambers, 2929 Tapo Canyon Drive, Simi Valley, California 93063. The Regional Board will hear any testimony pertinent to this discharge, the tentative requirements, and monitoring and reporting program. It is expected that the Regional Board will take action at the hearing; however, as testimony indicates, the Regional Board at its discretion may postpone action.

Written comments regarding the revised tentative WDRs must be received by the Regional Board by 5:00 PM on **November 14, 2018**. Comments on the revised tentative order are to be limited to the changes made since September 11, 2018, as noted using underlining (for insertions) and strikethrough (for deletions). Comments received after this date will not be accepted into the record unless determined by the Chair of the Regional Board not to prejudice any party or the Regional Board. See the enclosed Notice of Opportunity to Comment and Public Hearing.
