TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS - AZUSA LAND RECLAMATION LANDFILL, WASTE MANAGEMENT, INC., AZUSA, CA (FILE NO. 59-102)

Dear Mr. Anderson:

Reference is made to the tentative waste discharge requirements (WDRs) for the Azusa Land Reclamation Landfill, that were transmitted to you on June 3, 2009, for your review prior to consideration at the July 16, 2009, Regional Board public meeting. Because of comments received, the WDRs were continued to the September 3, 2009, public meeting.



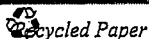
