TENTATIVE WASTE DISCHARGE REQUIREMENTS – BRADLEY LANDFILL AND RECYCLING CENTER, WASTE MANAGEMENT, INC., SUN VALLEY, CA (FILE NO. 78-027)

Section 13263 of the California Water Code provides for the periodic review and revision by the Regional Board of waste discharge requirements (WDRs) for landfill facilities. Since Bradley Landfill and Recycling Center (Landfill) ceased receiving waste on April 14, 2007, Waste Management Inc. (WMI) has been conducting final closure activities at the Landfill which are expected to be completed approximately November 2010. The WDRs for the Landfill (Regional Board Order No. 94-059, adopted May 13, 1994) are being revised because they no longer accurately reflect current conditions.

In accordance with administrative procedures, this Regional Board, at a public meeting to be held on November 4, 2010, beginning at 9:00 am., at the Metropolitan Water District of Southern California, 700 North Alameda Street, Los Angeles, CA 90013, will consider adoption of the enclosed tentative requirements and written comments regarding any or all requirements thereof. It is expected that the Regional Board will take action at the meeting, however as testimony indicates, the Regional Board at its discretion may order further investigation.

In order to be fully evaluated by Regional Board staff and included in the Regional Board's agenda packet, written comments must be received at the Regional Board's office by 5:00 pm on October 18, 2010.
