NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT AND PUBLIC MEETING ON TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR HOLLANDIA PRODUCE, LLC (FILE NO. 11-187, ORDER NO. R4-2023-XXXX, CI-10016, GLOBAL ID WDR100001875)

The Los Angeles Regional Water Quality Control Board (Los Angeles Water Board) will hold a public hearing to consider issuance of Waste Discharge Requirements (WDRs) to Hollandia Produce, LLC which operates a hydroponic lettuce growing facility located at 6135 North Rose Avenue, Oxnard, California. The WDRs, if adopted, will permit the operation of two evaporation tanks for the management of wastewater at the facility prior to offsite disposal.
